**DESCRIPTION OF AWARD**

The Stellar Club Award recognizes the clubs who demonstrate excellence in the following areas: Club in Good Standing, Service, Contribution, Membership, Leadership Development, Marketing & Communication, Club Development, and Club Assessment.

D50 Hawaii Lions Clubs who **complete** the Stellar Club Award application will be eligible for the Stellar Club Award. Awardees will receive a Stellar Club banner patch and a certificate.

There is **no tally key** for the Stellar Club Award application, all requirements must be accomplished.

**ELIGIBILITY**

- Chartered for six or more months prior to the end of the fiscal year
- Remained in “Good Standing,” such as District dues paid and no unpaid balance with LCI greater than \$50 outstanding 90 days or more. Club not in financial suspension.
- Completed and signed the application

**CRITERIA**

**Club in Good Standing**

- See above eligibility requirement

**Service**

- Club has conducted at least four of the eight Global Causes service (one of which is a new or improved project)

**Contribution**

- Club has contributed to the Hawaii Lions Foundation and the Lions International Foundation

**Membership**

- Club achieved a positive growth in membership or sponsored a club or branch
- New members attended an orientation and properly inducted into the Lions club
- Club had at least one New Proud Lion Awardee
- Club suggested a topic for Best Practices and offered to be a speaker
- One member of the club is a certified Guiding Lion
- Any two members attended at least three Best Practices Zoom Meetings

## **Leadership Development**

- At least three members furthered their leadership skills by participating at Leadership Institute, Lions Forums, Lions International Learning Center, LI sponsored webinar, or a speaker at one of the Best Practices Meetings

## **Marketing & Communication**

- Publicize club service through at least three mediums including club website, Facebook, Instagram, Twitter, local paper, radio, TV, flyers newsletter, club presentation to another organization

## **Club Development**

- Club hosted regular club meetings, entered service activities in the Lions Portal, and entered officers for the 2025 - 2026 year

## **Club Assessment**

- Club did an annual review of its operations, assessed comments from members and the public, and made necessary changes for improvement
